

'CONSENT-TO-ESTABLISH' (NOC)
UNDER SECTIONS 25/26 OF THE WATER (PREVENTION & CONTROL OF POLLUTION) ACT, 1974 AND UNDER SECTION 21 OF THE AIR (PREVENTION & CONTROL OF POLLUTION) ACT, 1981.

Reference application no. 29534, dated: 29.09.2010 of M/s Ramco Industries Limited, Proponent: Mr. R. Soundarajan, Sr. Vice President (Works), AURAS Corporate Centre, VI Floor, 98A, Dr. Radhakrishnan Road, Post Box no.-8949, Mylapore, Chennai -600004 for setting up a plant for production of Asbestos Fibre Cement Sheets & Accessories at Plot- A1, Industrial Area, Bihiya, Dist- Bhojpur with capacity- 120,000TPA.

2. AFTER CONSIDERING:

(i) The facts stated in their Application & Project report;

(ii) Bihar State Pollution Control Board's Notification No. 26, dated 08.11.2003;

(iii) Provisions of the Water (Prevention and Control of Pollution)Act, 1974 and the Air (Prevention and Control of Pollution)Act, 1981;

(iv) Provisions of The EIA Notification, 2006 and the amendment therein.

3. CONSENT-TO-ESTABLISH (NOC) IN FAVOUR OF THE PROPONENT AT THE SAID SITE IS HEREBY ACCORDED SUBJECT TO THE FOLLOWING CONDITIONS:

That, they shall obtain prior Environmental Clearance (EC) from MoEF, Govt. of India under the EIA notification, 2006. The notification prohibits any construction of new Project activity unless prior EC is obtained.

(ii) That, they shall comply with the directions as per the EC;

(iii) That, they shall have adequate pollution control facilities as per the EC;

(iv) That, they shall obtain consent-to-operate under section 25/26 of the Water Act, 1974 and u/s 21 of the Air Act, 1981 prior to commissioning of the plant from this Board.

(v) That, the effluent (Domestic & Trade) and emission, if any, shall

conform to the standard as prescribed by the Board;

(vi) That, they shall procure the D.G set to meet the standard as per the Notification in the Environment (Protection) Rules, 1986 and the amendments therein;

- (vii) That, the unit shall ensure the transportation of raw materials from source must be in environmentally condition.
- (viii) Rain water harvesting arrangement shall be done.
- (ix) Tree plantation shall be done and maintained in and all around the proposed site.

NOTE:

- The Bihar State Pollution Control Board reserves the option to revise or add other conditions, if necessary, for protection of Environment in general and for pollution control in particular.
- The present NOC should not be construed as an assurance for the grant of 'Consent-to-Operate' the proposed plant but shall be subject to compliance of all the conditions indicated above.
- 3. The NOC is valid for a period of twelve months from the date of issue.
- 4. Issued by the order of competent authority.
